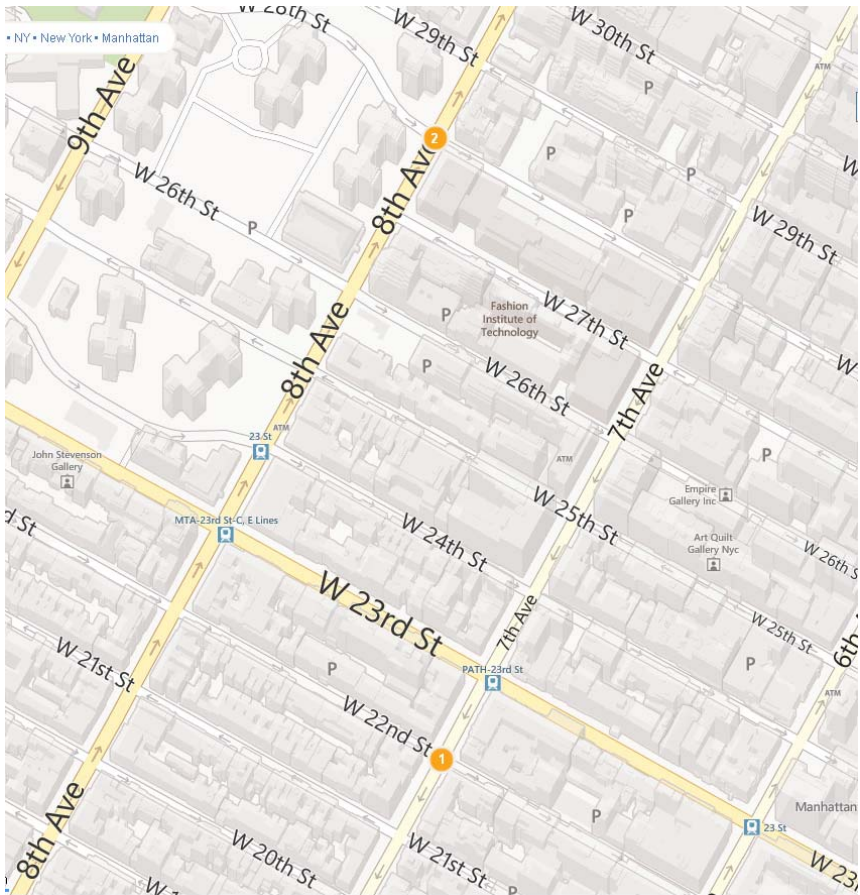


# Motorcycle & Scooter Parking Manhattan Community Board 4 Transportation Planning Committee The New York Motorcycle & Scooter Task Force

## Recommendations:

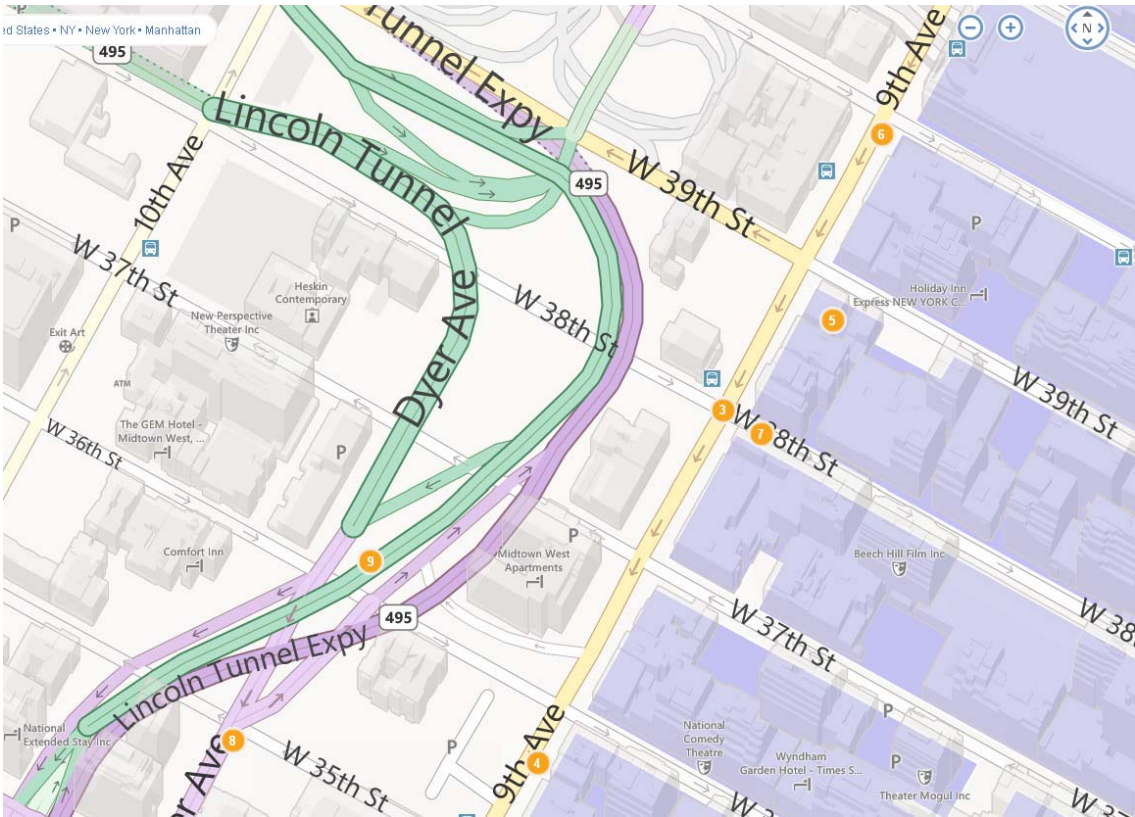
1. Implementation of motorcycle-only spaces *already approved* by CB4 in June 2010.
2. Identification of “Motorcycle Parking Only” on raised triangle north of Dyer Plaza, across 36th st.
3. Creation of five new motorcycle-only spaces in the area of the new Dyer Plaza.

- ③ 9th Ave., west  
side, south of 38th
- ④ 462 9th Ave.

- ⑥ 9th Ave., S of 40th  
st., West side
- ⑦ 38th st. E of 9th  
Ave. *Approved June 2010*
- ⑧ Dyer Ave. S of  
35th st., East Side
- ⑨ North of Dyer  
Plaza Triangle





- ① Southwest corner of W22nd St. & 7th Ave., 28' or 7 motorcycle & scooter spaces. *Approved June 2010*
- ② Northwest corner of W28th St. & 8th Ave., 24' or 6 motorcycle & scooter spaces. *Approved June 2010*
- ⑦ 38th st. E of 9th Ave., starting 15' from the fire hydrant, 24' or 6 motorcycle & scooter spaces. *Approved June 2010*

③ 9th Ave., west side, south of 38th ., between hydrant zone and pedestrian island, sufficient for 4 motorcycles.



④ 462 9th Ave. North of bicycle rack. Room for 4 motorcycles or scooters. Too small for a car.

Current: 3h commercial vehicles 7a-7p

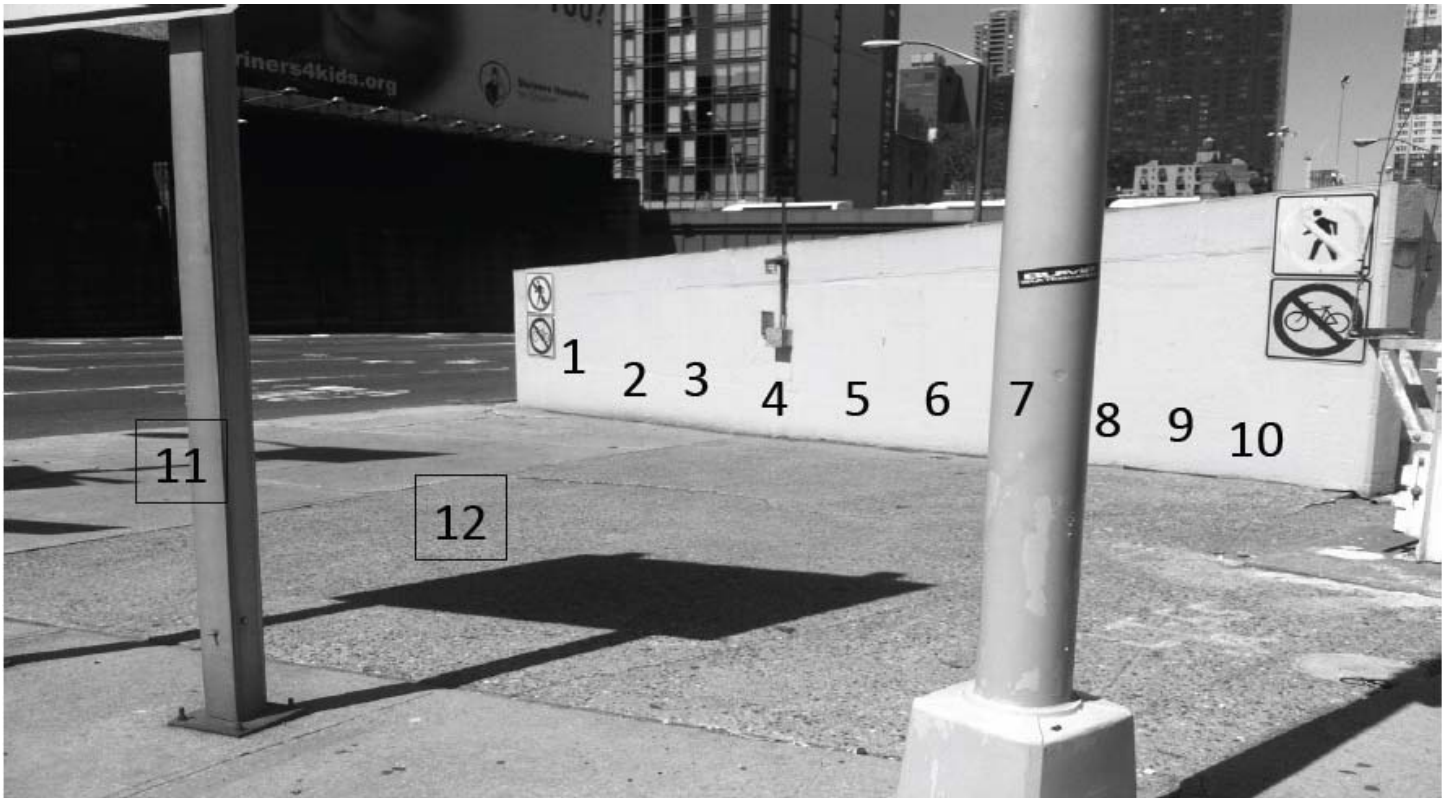


⑥ 9th Ave., S of 40th st., West side, north of  
bicycle rack. Room for 7 motorcycles.  
Current: 3h commercial vehicles 7a-7p





⑧ Dyer Ave. S of 35th st., East Side, Striped zone south of park could accommodate dozens of motorcycles and scooters, with minimal impact on traffic or community.
